I am hereby requesting authorization to gain access (including, but not limited to, the ability to view and/or transfer funds between certain accounts) via NetBanker, The Bank N.A.'s Internet Banking product, to all of my eligible accounts held at The Bank N.A. An eligible account is one on which I am an owner or authorized signer, or The Bank N.A. has received written authorization from the account owner, granting access to me. I understand and agree that The Bank N.A. may, at its sole discretion, make changes to my ability to access a certain account(s) through NetBanker, up to and including revocation of all authority and that such action does not require prior notification to me or my approval.

I understand and agree that access to my account(s) via NetBanker, if granted, will be accomplished through the use of a unique NetBanker ID and password combination. I have selected and/or been notified of the initial password (shown below) for use with my NetBanker ID, and understand for security purposes, I will be required to change that initial password the first time I log into NetBanker. I agree to assume full responsibility for the safety and security of my NetBanker ID and password, and will not allow anyone else to obtain and/or use them. Accordingly, I request The Bank N.A. to honor all authorized transactions made using my NetBanker ID and password and I agree to assume full and total liability for the resulting consequences of their use thereof. Should I become aware of suspicious or unauthorized transactions or should I have reason to believe that the identity of my NetBanker ID and password has somehow become compromised, I agree to inform appropriate personnel at The Bank N.A. immediately. Also, I understand that if I forget my NetBanker ID and/or password, I must contact the appropriate personnel at The Bank N.A. in order for it to be re-set, and that such procedure will be performed solely at their discretion and subject to their terms and conditions.

I acknowledge that I have received a copy of the Bank's Electronic Funds Transfer (EFT) disclosure statement, either at the time I originally opened my bank account or upon my submission of this application to appropriate Bank personnel. I agree that such Statement, as may be properly amended from time to time in accordance with its terms, will govern all transactions processed through NetBanker, and that my use of NetBanker will confirm that I have received and reviewed the EFT disclosure statement and agree to be bound by its terms and conditions.

I understand that The Bank N.A. may make revisions to NetBanker, along with the terms and conditions governing its use, from time to time without prior notice to me, although the Bank agrees to use its best efforts to notify me of any change that might be considered adverse. I hereby agree that my continued use of NetBanker after a revision has been made shall constitute my acknowledgement of, and agreement to be bound by, the revisions, and any corresponding changes to the terms and conditions governing its use. I understand this application is subject to validation with the Bank's records and upon subsequent approval I will be notified of my designated NetBanker ID number. I understand it may take up to five business days for the Bank to process this application request.
